S. R. O. No. 449/2018.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), the Government of Kerala hereby make the following rules further to amend the Kerala Homoeopathy Subordinate Service Special Rules, 2011 issued under G. O. (P) No. 441/2011/H&FWD dated 29th July, 2011 and published as S. R. O. No. 492/2011 in the Kerala Gazette Extraordinary No. 1549 dated 16th August, 2011, namely:—

RULE

1. *Short title and commencement.*—(1) These rules may be called Kerala Homoeopathy Subordinate Service (Amendment) Special Rules, 2018.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Kerala Homoeopathy Subordinate Service Special Rules, 2011,—

(1) in the Table under rule 3, against category 7, for item (2) and Note below it in column (2) the following entries shall be substituted, namely:—

“(2) (i) By promotion from Grade I Attender/Dispenser/
Nursing Assistant/Store Attender/Record Attender.

(ii) In the absence of qualified persons under item 2(i) above, by transfer from Grade II Attender/Dispenser/
Nursing Assistant/Store Attender/Record Attender.

Note:—Appointment by direct recruitment and by promotion shall be in the ratio of 1:1 starting with direct recruitment. In the absence of qualified Employees under the method of by promotion, those vacancies shall be filled by direct recruitment.”

(2) in the Table under rule 7,—

(i) against category 5, the existing item (2) in column (3), shall be substituted by the following, namely:—

“A pass certificate obtained after successful completion of Nurse-cum-Pharmacist Training Course (Homoeopathy)/ Certificate Course in Pharmacy (Homoeopathy) conducted by the Government of Kerala or its equivalent qualification recognised by the Government.”

(ii) against category 7, the existing item (2) in column (3) against (1) By Direct Recruitment and (2) By Promotion in column (2), shall be substituted by the following, namely:—

"A pass certificate obtained after successful completion of Nurse-cum-Pharmacist Training Course (Homoeopathy)/ Certificate Course in Pharmacy (Homoeopathy) conducted by the Government of Kerala or its equivalent qualification recognised by the Government."

- (iii) against category 9, the existing "Note" under item (2) in column (3), shall be substituted by the following, namely:—

"*Note*:— Those who passed Nurse-cum-Pharmacist (Homoeopathy)/ Certificate Course in Pharmacy (Homoeopathy) conducted by the Government of Kerala need not have to undergo the above said in-service training course".

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

There is acute shortage of qualified hands for the post of Pharmacist Grade II by direct recruitment. Therefore, an opportunity has to be provided to the experienced employees in Homoeopathy Department working in the lower cadre who possess the requisite qualification. In addition, Government in G. O. (Rt.) No. 4284/2010/H&FWD dated 30th October, 2010 have discontinued the Nurse-cum-Pharmacist Course and introduced Certificate Course in Pharmacy (Homoeopathy) vide G. O. (Rt.) No. 140/2014/H&FWD dated 15th May, 2014. Therefore, Government have decided to make suitable amendment in the Kerala Homoeopathy Subordinate Service Special Rules, 2011.

This notification is intended to achieve the above object.
